

GREAT PLAINS NO-TILL DRILL INVOICE AND LEASE AGREEMENT

I/we hereinafter referred to as Lessee, agree to lease the Great Plains No-Till Drill from the PUTNAM COUNTY SOIL CONSERVATION DISTRICT, hereinafter referred to as Lesser, pursuant to the provisions contained herein.

LESSEE acknowledges that he is familiar with the operation of the equipment leased and that he knows how to operate said equipment and will operate it in the manner in which a reasonable prudent person would operate the equipment. ***LESSEE is specifically aware the drill can be damaged due to turning or backing while said drill is engaged in the ground and will be responsible for any damage to bearings, press wheels, gear boxes, etc. caused by such action.***(_____).

LESSEE agrees to exonerate, protect, indemnify and save harmless the PUTNAM COUNTY SOIL CONSERVATION DISTRICT and BOARD OF SUPERVISORS, AND HULL-YORK LAKELAND RC&D COUNCIL, ITS OFFICERS AND DIRECTORS from and against any and all losses, damages, claims or suits which may arise or grow out of any injury to growing crops whether owned by *LESSEE* or to any other person whomsoever, or damage to property, or from damage arising out of any injury to the *LESSEE* or to any other person whomsoever, in any manner connected with the use and possession of said equipment and fixtures furnished by PUTNAM COUNTY SOIL CONSERVATION DISTRICT OR HULL-YORK LAKELAND RC&D to the *LESSEE*(_____).

LESSEE acknowledges that he/she has received the equipment in good workable condition and agrees to return said equipment in as good condition as it was received; ordinary wear and tear expected, and further agrees to comply with all laws, ordinances, rules or regulations of constituted public authorities applicable thereto (_____).

LESSEE shall be solely responsible for proper and safe connection of the drill to the pulling vehicle and will be responsible for any and all liability resulting from LESSEE'S possession of equipment (_____).

Payment in full will be made on date drill is returned.

The drill cannot be leased for more than three (3) consecutive days by the same individual without District approval. (Sunday is excluded from the three (3) day lease period)
